Said Plot shall be subject to the conditions and limitations set forth hereinafter:

1. Plot is to be used as a place of burial of human remains and for no other purpose.
2. Plot is subject to all rules and regulations of the King Cemetery and to whatever restrictions are imposed by Vermont law.
3. Four cornerstones with the initial “ \_\_\_\_\_ ” (first initial of plot owner’s last name) are to be placed on said Plot at the owner’s expense at the time of plot purchase.
4. Said Plot contains space for the burial of either: one (1) full-body plus burial of four (4) cremated remains, or two composted bodies plus burial of four (4) cremated remains.
5. Said Plot is not to be transferred or sold to any person or persons without the consent of the Town of Marlboro and only upon a signing of a new deed.
6. Town of Marlboro and Cemetery Commission officials reserve the right to enter upon said Plot at any time to make repairs or improvements deemed necessary.
